1. For purposes of this order the word "Organiser" will refer to **ELITE COUNSELLING SERVICES** having its office at A-284, Basement, Shivalik, Malviya Nagar, New Delhi – 110 017, INDIA and the word Exhibitor will refer to the person and / or company who has completed this booking order form.
2. **FURNISHED BOOTH PACKAGE** - Name panel, carpet, spotlights and power supply. 1 table, 2 Chairs & 1 wastepaper bin with 1 bottle of Mineral Water.
3. **PARTICIPATION CHARGES** – See in Stall Detail Sheet with Surcharge @ 10% Extra
4. The booking of space has to be made along with an advance payment of 100% by way of Demand Draft (DD) or Pay Order (PO) payable in New Delhi in Favour of "ELITE COUNSELLING SERVICES" along with the Stall Booking Contract Form duly filled and signed by a competent authority and should be delivered to The Director, Elite Counselling Services, A-284, Basement, Shivalik, Malviya Nagar, New Delhi – 110 017 latest by **1st of March, 2007**.
5. Exhibitors are requested to note that all floor plans shown in the **Stall Detail Sheet** are tentative and the organizers reserve the right to amend the same. Further, the organisers are not liable for any change in the venue / date arising from circumstances beyond their control.
6. In case of the event being cancelled or suspended in whole or in part for causes not in the Organiser's control, the Organisers do not accept any consequential liability in any such eventuality; Disputes are subject to New Delhi Court Jurisdiction.
7. The rates do not include charges for extra lighting or decoration, demonstrators or sales personnel etc, which may be arranged on specific requests at extra cost which can be paid by cash at the venue.
8. Although arrangements for round - clock security will be made by the organisers, the participants will be solely responsible for the safety of their goods.
9. Participants will be fully responsible for any damage done to the premises, furniture and fixtures provided to them, and the decision of the organisers in this respect will be final.
10. Allotment of stall location will be generally on a first come-first served basis. The organisers reserve the right to allot stall locations as per categorisation and their decision in this regard shall be final.
